# NOTICE INIVITING TENDERS NIT NO.- 02/SASB/DRUGS(HOMOEOPATHY) 2023-24

- 1. The Executive Director, State Ayush Society, Bihar (SASB), Department of Health, Government of Bihar, Patna(hereinafter referred as "Tender Inviting Authority or TIA") intends to select bidders (manufacturers/suppliers/importers) via e-tendering for the award of rate contract for supply of homoeopathic medicines/consumables across government homeopathic clinics/ dispensaries situated in the State of Biharas per specifications mentioned in Annexure-I of Request for Proposal on "door delivery basis" for a period of 2 years from the date of signing rate contract agreement.
- 2. The rate contract with successful bidders(manufacturers/suppliers/importers) will be signed with State Ayush Society, Bihar (SASB).

- 6. The tender shall be accompanied by **Tender Fee (Non-Refundable)** of Rs. 10,000/- + GST @18%, Total Rs. 11,800/- shall be submitted online via e-proc 2 portal. This fee is payable only once for one tender irrespective of items contained therein.
- 7. The tender shall be accompanied by **Earnest Money Deposit** (EMD)as applicable as mentioned under Section-2 (Instructions to the Bidder); Clause- 4(b)in offline mode only in the form of Bank Guarantee (BG) issued by a scheduled Bank in favour of State Ayush Society, Bihar.
- 8. **Tender Processing Fee (TPF)** amountas applicable to be paid by the bidder through e-Payment mode (i.e. NEFT-RTGS, Internet Banking, Credit / Debit Card) only, to the agency empanelled by Government of Bihar for centralized e-Procurement.
